Why does our educational system need the services of PHI teachers? On 11/2/06, an article appeared in the Wall Street Journal about nursing shortages in U.S. public schools. This article related the frightening story about a boy with Type I diabetes who required close monitoring. The school nurse, like so many in public schools today, had to cover multiple campuses. If the student were to slip into a diabetic coma, the nurse would not be able to make it back to his school in enough time to prevent potential neurological damage. Federal guidelines recommend that school nurses be assigned to no more than 750 children, yet approximately 59% have more students than that. In California, the average school nurse is responsible for more than 2,000 students. PHI teachers have knowledge about many of the medical conditions that close to 20% of children in public schools present with and can provide valuable training and information to staff working with these children. We also assist staff by providing curriculum support so our students can access appropriate curriculum with the adaptations they require.

All of you should be commended for the incredible work you do everyday. Even though some of our students cannot tell you in so many words, they appreciate what you do, and their parents are especially grateful. Our goal is to make sure our colleagues do as well! Have a wonderful 2007 and join us in beautiful San Diego!
